Lonnie Perry spoke of concerns he has about disabled persons in Au Train Township being able to handle the new garbage cans to be delivered to township residents.

Discussion - Proposed Zoning Ordinance Amendments:

Various questions and concerns on the proposed zoning ordinance amendments were brought up and discussed. Following are some of the items to be reviewed:

- In an effort to reduce the number of potential nonconforming land uses and streamline the amendment process, should potential township rezoning efforts occur in conjunction with the amending of the zoning ordinance?
- Revisit that the definition of Recreational Vehicle includes "pickup camper"
- Try to come up with language so that "structures" such as deer blinds do not require a zoning compliance permit.
- Revisit the language covering under what conditions a CUP may be revoked.
- Making a short-term rental a permitted principal use in the Township Development district.

Discussion - Undocumented Short-term Rentals:

Some of the topics discussed regarding undocumented short-term rentals were:

- Some short-term rentals may be claiming the Homestead exemption on their property taxes.
- There are companies which document and monitor short-term rentals for the township.
- Should the township consider using short-term rental density as a restricting metric?
- Should the 16-mile Lake area be rezoned?
