# Discussion on amendments to the Twp. Zoning Ordinance / Zoning Map

- The time period by which the ZA shall respond to a Zoning Compliance Permit request was changed from seven "working" days to seven "business" days. Similarly, the time period by which the ZA shall review a site plan was changed from ten "working" days to ten "business" days.
- The requirement that the ZA respond to a Zoning Compliance Permit request by certified mail
  was removed in favor of allowing the applicant to choose their preferred method of
  communication of US mail or email.
- The requirement that a site plan be submitted on 24" x 36" paper was removed.
- The definition of Short-term Rental was adjusted.
- General Regulations for short-term rentals and recreational structures were added.
- New subsections were added to <u>Section 304 Application of District Regulations</u> stating:
  - Uses not listed within a particular Zoning District are prohibited in that particular Zoning District.
  - An approved Zoning Compliance Permit is required prior to the establishment of a Principal Use or an Accessory Use.
  - An approved Conditional Use Permit is required prior to the establishment of a Conditional Use.
