Discussion on amendments to the Twp. Zoning Ordinance / Zoning Map

- A discussion on the Right to Farm Act and General Accepted Agricultural and Management Practices (GAAMPS) resulted in the following:
 - The following definitions were deleted: Agricultural Activity, General; Agricultural Activity, Intensive; Farm; Feed Lot; Fur Farm
 - A definition for Agricultural Activity was added.
 - The definition of Hobby Farm was adjusted.
 - Agricultural Activity and Hobby Farm were included as principal or conditional uses of selected districts.
 - A new General Regulations section was added which incorporates Michigan's Right to Farm Act and General Accepted Agricultural and Management Practices (GAAMPS).
- A new paragraph was added to <u>ARTICLE VIII CONDITIONAL USE PERMITS</u>, <u>Section 801 -</u> <u>Intent</u> stating: The applicant of a Conditional Use Permit should be prepared to explain how the requested conditional use meets each of the standards listed in <u>Section 802 - Basis of</u> <u>Determination / General Standards</u> which are applicable to their request.

WHEREAS Public Act 110 of 2006 - Michigan Zoning Enabling Act; authorizes a Planning Commission to review, plan and recommend Zoning Ordinance Amendments and map adjustments to the Township Board;

AND WHEREAS the Planning Commission has been thoroughly reviewing the current Au Train Township Zoning Ordinance and Official Zoning Map for the past 3 years;

AND WHEREAS the review has justified corrections, updates and changes to the Zoning Ordinance and the official Zoning Map, to reflect current land uses within the Township;

AND WHEREAS the Planning Commission at a special meeting held on June 8, 2022, voted to send their recommended updates to the Zoning Ordinance and Zoning Map to the Township Board for approval;
